 a. The Division requires all fire districts to have at least one official enrolled in the internet-based GovConnect network to receive Division and other state government information via e-mail.
 Once enrolled, an authorization link must be set up for specific Fire District information.

- d. The website has had the attention of the public and the Division does receive a lot of feedback in non-compliance issues with the Websites. If the Officer is certifying the form, please make sure the website is in full compliance with the statue.
- e. 2022 Budget Submission
- f. Budget submittal and Hearing Dates.
- g. Please be mindful of the statutory due date for all 2022 Fire Districts which is 2/19/2022. There is only a small window of time for submittal, examinations, and approval. Due to the high volume of Fire District budgets in the small window submit their introduced budget as early as possible rather than waiting until the statutory due date.
- h. Revenue/ grants/sale of Assets-
- i. When including the anticipated revenue in the budget please include back -up documentation of the revenue for example: the grant award letter and/or a completed contract for the sale of the assets. If the back -up documentation cannot be presented a budget amendment would be required. If it was the sale of an asset, the asset can still be sold, and the revenue would just go into surplus.
- j. Variances over +/- 10%-
- k. Attach any supporting documentation that will help to explain the reason for the increase in the budgeted line item.
- I. Capital Appropriations
- m. Chief's vehicles (Special purpose vehicles)
- n. A vehicle used for responding to fire calls, is considered a special purpose vehicle for the purpose of determining useful life of the vehicle and (not a passenger vehicle) to have a useful life of 5 years or more as defined in NJSA 40A:2-22.
- All required documentation will be required for any special meeting and/or special election before budget approval will be granted.
- p. Election Results should be submitted to the director within 3 days after the annual election in February. Failure to submit election results will delay the certification of taxes to the municipality. The Division requires a copy of the Election Ballot to be submitted along with the Election Results.
- q. Audit Report- To be submitted thru FAST. Many are Outstanding.

Existing Statute- New budget compliance

Municipal Approval of Elected Commissioners Compensation

 New this year- Each district must report commissioner salaries and have a resolution passed by the mayor's office. To get the budget approved

Question will be asked in the budget questionnaire Appropriate resolutions must be uploaded in FAST.

2021 Fire District Convention - FAST

- 1) Fire districts will submit budget through FAST as they did last year electronic system where you upload and submit budget to the Division.
- 2) Standard excel spreadsheet- available on website FAST and Authority Budgets and Portal.
 - a. Single form locked, formatted, etc.
 - b. Anyone can access and work on form.
 - c. Instructions are in workbook and online, information flows, reducing data entry.
 - d. New this year Expanded and shortened sections.
- Uploading to FAST:
 - a. Only designated fire district officials can access FAST to upload and submit.
 - i. Secretary to Board, Board Treasurer, Full-time Administrative Staff.
 - ii. Contracted preparers can complete our documents but cannot be the ones to upload and submit.
 - iii. New to FAST google "NJ DCA FAST", first result is website, link to portal on website. "New Users". Register w/ name, email, username, password. Once logged in, click "Request Access", select your fire district and submit.
 - All the supporting documentation that you would normally mail with your budget should be uploaded as an attachment in FAST.
 - i. Separate "slot" for each attachment.
 - c. Must click "Submit" to actually send to the division. You will receive email confirmation.
 - d. Place in FAST for introduced and Adopted Budgets.
 - Elections in February for budget, capital, levy cap, restricted fund balance must be reported in FAST in the adopted section

NEW JERSEY STATE ASSOCIATION OF FIRE DISTRICTS ANNUAL REPORT BY LYNN NOWAK SEPTEMBER 17, 2021

AMERICAN RESCUE PLAN -LOCAL NATIONAL FISCAL RECOVERY FUNDS

"Special purpose units of local government are not eligible for funding allocations." "Special purpose units of government perform specific functions in the community such as fire...." However, "a state and may transfer funds to a special purpose unit of local government." We need the state to transfer the funds to the fire districts. Regarding for what purposes a fire district could make the case for fund eligibility: funds can be utilized for "reduction of revenue forand FIRE and other public safety services."

We met with John Butler, policy advisor to the Governor on these issues on Sept 15, 2021

CAPITAL PURCHASES

A2352, Dancer/Murphy – Permits fire districts to undertake capital projects upon resolution of board of fire commissioners. (Removes the voter approval mandate for fire district capital purchases and debt issuances.)

Introduced on Feb 3, 2020 and referred to the Assembly State and Local Government Committee.

We had a call with Senator Bob Smith on Dec 4, 2020 asking him to sponsor the bill in the upper house. He was frank and advised that he did not believe that the legislature would be amenable to removing voter approval on anything at this time. He suggest that we look at the statute that provides school districts with another option when voters reject a capital construction referendum. He said he would be happy to take that to the Office of Legislative Services to draft a bill tailored to fire district needs and he would sponsor it. I found the statute (short title below). Rich and I agree that it is not ideal and we need to work on the language.

N.J.S.A. 18A:7G-12 provides that a school district that has unsuccessfully sought to obtain voter approval for school facilities construction twice in a three-year period may apply to the Commissioner of Education for approval to issue school bonds for the local share of the project.

MOVING FEBRUARY ELECTIONS TO APRIL AND IN PERSON

On December 21, 2020, Governor Murphy issued an executive order moving February fire district elections to April. He subsequently issued a notice that the April elections would be in person and two other executive orders on this topic. Please note that Governor's Counsel's

office communicated with me on this on an ongoing basis and set conference calls with representatives from DCA on which Rich and I participated to provide input.

EXEMPT FIREMAN CERTIFICATES

A4745, Armato - Raises from 45 to 57 maximum eligibility age for exempt fireman certificates and membership in New Jersey State Fireman's Association.

S1634, Doherty – Raises from 45 to 60 maximum eligibility age for exempt fireman certificates and membership in New Jersey State Fireman's Association.

These bills were made identical – age of 57. After passed both houses unanimously, Governor Murphy signed it into law on June 24, 2021: P.L. 2021, c. 123
I registered the Association's support for the legislation as it have moved through the process.

JUNIOR FIREFIGHTERS

\$238, Singleton/**A2899**, Space/ **A1106**, Murphy - Revises law governing training and duties of Junior Firefighters' Auxiliary members.

S238 was heard and released by the Senate Law and Public Safety Committee on Jan 30, 2020. I registered the support of the Association. It passed the full Senate unanimously on Feb 10. It was heard and released by Assembly Homeland Security and State Preparedness Committee on Oct 19 and passed the full Assembly unanimously on Oct 29. The Senate concurred on Assembly amendments on the same date.

Signed into law, Nov 20, P.L. 2020, c. 126

SHARED SERVICES

\$1, Sweeney/A3389, McKeon – Encourages sharing of services.

Senate President Sweeney has this bill moving again: it was heard and released by the Senate Budget and Appropriations Committee on Feb 11, 2021 and passed the full Senate on June 3, 2021 (31-0). It was referred to the Assembly Commerce Committee.

STATE FIREMEN'S HOME

A5210, Burzichelli – Revises composition and certain functions of State Firemen's Home.

Both Craig and Rich contacted me and said that this had many in fire service very angry. I have spoken to the sponsor's chief of staff and he does not intend to move it in the near future.

Then, in a very rare move for the NJ Legislature, the sponsor withdrew the bill from the files on June 9, 2021.

FIRE MUSEUM

A5075, Burzichelli/ **S4001**, Sweeney – Removes Fire Museum and Fallen Firefighters Memorial From auspices of DEP and establishes independent organization.

Passed the Assembly (72-1) on March 24, 2021 and the Senate (40-0) on June 24, 2021. It needed to return to the Assembly for concurrence on Senate amendments.

WATER COMPANY MANDATES

A1330, Mosquera/Murphy – Prohibits water companies from assessing more than one charge per fire hydrant to fire departments, fire districts or volunteer fire companies for use of fire hydrants.

A1330 was introduced on Jan 14, 2020 and referred to the Assembly State and Local Government Committee. It is awaiting a hearing in committee.

A1331, Mosquera/Murphy— Requires water companies to provide representative of fire department, fire district or volunteer fire company access fire hydrants for water flow rate testing purposes.

A1331 was introduced on Jan 14, 2020 and referred to the Assembly State and Local Government Committee. It is awaiting a hearing in committee.

No further action

LIGHT FRAME CONSTRUCTION

S2051, Weinberg - Establishes fire safety standards and protocols for certain light frame residential construction; requires project labor agreements for this construction; requires placards identifying primary structural systems of buildings.

Scheduled to be heard by the Senate Community and Urban Affairs Committee on Mon, Sept 21, 2020 but it was held.

No further action.

IMMUNIZATION FROM CIVIL LIABILITY

A306, Danielson/**S1648,** Lagana – Provides immunization from civil liability for first responder who forcibly enters property to provide emergency assistance.

A306 passed the full Assembly on July 30, 2020 (73-1). S1648 was introduced on Feb 13, 2020 and referred to the Senate Judiciary Committee.

No further action.

FIRE SAFETY/FIRE SUPPRESSION SYSTEMS/FIRE EXTINGUISHERS /SMOKE ALARMS

A5200, DeAngelo/ **S1406**, Pennachio - Requires bidders on public works construction projects to submit information on fire safety features.

A5200 was released by the Assembly State and Local Government Committee on May 12, 2021 and is awaiting consideration by the full Assembly. No action in the Senate.

A1656, Quijano/S1805, Ruiz – Requires fire suppression systems in new single and two family homes.

A1656 was introduced on Jan 14, 2020 and referred to the Assembly Housing Committee. It has not yet received a hearing in committee. S1805 was introduced on Feb 24, 2020 and referred to the Senate Community and Urban Affairs Committee, and likewise has not yet been heard.

No further action

A2600, DeAngelo/**S1518**, Greenstein – "New Townhouse Fire Safety Act"; requires automatic fire sprinkler systems in new townhomes.

Both bills were introduced on Feb 13, 2020 and referred to committees, in the Assembly to Assembly Housing Committee, in the Senate to Senate Community and Urban Affairs Committee.

No further action. NOTE: This bill passed both houses last session but was pocket vetoed by Governor Murphy.

A859, Chiaravalloti - Requires Division of Fire Safety to annually distribute smoke alarms; appropriates \$1 million.

A859 was introduced on Jan 14, 2020 and referred to the Assembly Housing Committee. It has not yet had a hearing.

No further action

OPMA AND OPRA REFORM

A748, Johnson/S379, Weinberg – Reforms Open Public Meetings Act; Both bills were introduced on Jan 14, 2020. A748 was referred to the Assembly State and Local Government Committee, S379 was referred to the Senate State Government, Wagering, Tourism and Historic Preservation Committee, neither has had a committee hearing yet.

A749, Johnson/S380, Weinberg – Reforms Opens Public Records Act.

Both bills were introduced on Jan 14, 2020. A749 was referred to Assembly State and Local Government Committee, and S380 was referred to Senate State Government, Wagering, Tourism and Historic Preservation Committee.

No further action BUT MAJORITY LEADER WEINBERG HAS INDICATED THAT SHE IS MAKING THIS ONE OF HER LEGACY ISSUES IN THE LAME DUCK BEFORE SHE RETIRES.
